STUD OWNER AND BITCH OWNER AGREE:

1. STUD OWNER GUARANTEES THREE, LIVE AND HEALTHY PUPPIES. Any pups that do not meet the breed standard must be marketed or placed by the bitch owner on a limited registration and alter contract.

2. Bitch Owner will furnish Stud owner with a photo of each pup listing sex and color within 3 days of birth.
3. Puppy's eyes must be cleared by a certified ophthalmologist no later than the litter turning 8 weeks of age with copy to Stud owner. Any pup not passing must be sold on limited registration and alter contract.
4. Bitch owner shall furnish stud owner with name, address, and phone and e mail of each new owner of a pup.
5. On pick puppy, Stud owner shall bear the cost of picking up the pup, travel, health clearances etc. Pick pup shall be chosen prior to the litter turning 8 weeks.
6. Stud fee is due on or before 7 days from the whelping of 3 or more live pups.
7. If no live pups result a new contract must be negotiated.
8. This contract is legally binding on all heirs and assigns. The contract may not be amended unless signed in writing and agreed to by all parties.
9. If either party feels there is a breach of this contract, suit shall be brought in the county and state of the Stud Owner.
